The Italian Agency for Development Cooperation (AICS), as the Contracting Authority, informs all potential applicants to this Call for Proposals that the deadline for the submission of Concept Notes is extended to **29/03/2019**. All concept notes must be sent before the date for submission, as evidenced by the date of dispatch, the postmark or the date of the deposit slip. In the case of hand-deliveries, the deadline for receipt is **29/03/2019, before 12 hours local time (Tunis)**, as evidenced by the signed and dated receipt. Any concept note submitted after the deadline will be rejected.
