**Programme**: "Recovery, Stability and Socio-Economic Development in Libya / Baladiyati – Phase 2 (RSSD 2/Baladiyati 2)"- T05-EUTF-NOA-LY-13 (T05.1849) (hereafter referred to as "the Programme"), financed by the European Union and executed by the Italian Agency for Development Cooperation (AICS), the United Nations Development Programme (UNDP) and the United Nations Children's Fund (UNICEF).

The AICS Tunis Regional Office intends to recruit an International Programme Officer (M&E) for the implementation of the programme "Recovery Stability and Socio-economic Development in Libya – Baladiyati Phase 2".

# PROGRAMME BACKGROUND

Within the framework of the European Union "Emergency Trust Fund for Stability and addressing root causes of irregular migration and displaced persons in Africa" (i.e., "Trust Fund"), the Programme responds to the effects of the ongoing instability and difficult socio-economic conditions of the most

vulnerable populations in the south of Libya. It targets municipalities with high concentration of migrants and asylum seekers, settled or in transit, areas of displacement of Libyans and places to which displaced populations are returning, as well as communities where basic service infrastructures and livelihood have been severely affected by the conflict.

In the selected municipalities the EU Action shall improve living conditions for the most vulnerable, including local communities, migrants, and refugees, in an inclusive and conflict-sensitive manner by enhancing access to basic and social services. Moreover, it will tackle lower economic development, social cohesion and community security specifically affecting southern Libya. The Action will therefore aim at supporting activities that can respond to immediate needs at the local level, while also laying the groundwork for longer-term, more sustainable programmes.

The Programme started in June 2021 and has a 36-month duration.

#### **TERMS OF REFERENCE**

**Duty station**: Tunis, with missions to Libya and possible relocation to Libya as soon as the security clearance is obtained.

Contract and Remuneration: salary, benefits and other conditions are offered in accordance with AICS rules and regulations, in particular: "Criteri e modalità per la selezione di personale non appartenente alla Pubblica Amministrazione da assumere con contratto di diritto privato a tempo determinato disciplinato dal diritto locale" as provided for by the Delibera CC n. 101 dated 19 November 2019 and the Determination of the Director of the Italian Agency Development Cooperation number 28/2021 of 05 February 2021. The salary and benefits will be determined on the basis of professional seniority, specific professional qualification and level of competence in relation to the responsibilities and specific tasks that the successful candidate will be required to perform.

The expected gross salary per year will be in the range between EUR 37,519 and EUR 41,270 plus a Country adjustment for Tunis duty station. Benefits could be considered based on the candidate's experience and competencies. In case of relocation to Tripoli, the country adjustment/quality of living allowance and risk allowance will be adjusted in accordance with AICS salary scale.

**Duration**: Twelve months – including a two-month probation period – with possible extension subject to needs, availability of funds, satisfactory performance and duration of the Project.

## 1. KEY FUNCTIONS

Under the overall supervision of AICS Regional Representative in Tunis and the direct supervision of the PMU Team Leader, the International Programme Officer— M&E supports the correct implementation of the Programme in close collaboration with the PMU Team (based in Tunis and Tripoli), and in consultation with relevant AICS and Embassy officials in Tunis and Tripoli.

In particular, the Programme Officer will:

- 1. Provide overall technical and operational support to the work of the Programme Management Unit (PMU), including the preparation of technical documents and reports;
- 2. Assist in the preparation and evaluation of tenders for service contracts and calls for proposals for grants, in monitoring the technical implementation of contracts and outsourced services, in the report review/clearance and relevant follow up action, including payment requests;
- 3. Contribute to partner and stakeholder relationships, including liaison with the EU Delegations/Headquarters, UNDP and UNICEF partners, Programme Governing Bodies, as well as with the concerned Libyan stakeholders at central and local level (e.g. Ministries and municipal authorities);
- 4. Assist in the interaction between the PMU and (i) implementing partners/service providers, with regards to programmatic and security matters; (ii) Libyan central and local authorities to expedite operations (e.g. custom clearance, approvals, etc.); and (iii) in AICS with regard to administrative, procurement, legal, and financial compliance;
- 5. Contribute to the development of concepts and innovative approaches to best achieve the expected results;
- 6. Perform other relevant activities as required.

Prohibition to engage in other activities: The selected candidate must not have carried out, during the last three years, any business activity in the country of service, or be in a situation of conflict, even potential, of interests that undermine the impartial exercise of the functions, as provided for in Article 53 of Italian Legislative Decree no. 165 of 2001, referred to in Law No. 190 of 2012 and by the AICS Code of Ethics and Conduct referred to in point 7 below. The Administration reserves the right to verify, under penalty of exclusion, the compliance of what has been declared in this regard by the selected candidate.

### 2. REQUIREMENTS

#### 2.1 Essential Requirements:

Candidates will be considered eligible for selection on the basis of the following "essential requirements," to be fulfilled by the deadline for applications:

- 2.1.1 Age not exceeding (at the time of signing the contract) that required for retirement by local regulations (60 years), or by Italian regulations (ref. Law 398/87) for candidates subject to the Italian social security system (67 years);
- 2.1.2 Medically fit for employment;
- 2.1.3 Master's degree in international Relations, Political and Social Sciences, Economics, International Development or related fields (level 7 European Qualification Framework EQF) or in another field accompanied by proven experience in the sector as specified in the vacancy announcement of at least 3 years working experience *in addition* to those provided for in the following point 2.1.4;
- 2.1.4 At least 5 years of relevant working experience in project monitoring, data collection, analysis and reporting;
- 2.1.5 At least 2 years of relevant professional experience working with international organizations, governmental and/or non-governmental aid bodies on socio-economic development and/or humanitarian relief projects and programmes, in developing countries
- 2.1.6 Proficient in written and spoken English (C1 Level Common European Framework of Reference);
- 2.1.7 Proficient Italian language user (C1 Level Common European Framework of Reference);
- 2.1.8 Proficient in the use of Microsoft Office applications;
- 2.1.9 Not having sustained, in the three-year period preceding the date of expiry of the notice, an assessment of insufficiency of work done/performed in the context of employment contracts signed with AICS offices other than Tunis.

The requirements set out in this article must be fulfilled throughout the duration of the contract.

governmental and non-governmental bodies;

2.2.5 Similar professional experience carried out in the country indicated in this vacancy notice and/or in fragile states and/or in the MENA region.

Before submitting their application, candidates should assess whether they fulfil all the essential requirements specified in this vacancy notice. Professional experiences indicated in the curriculum vitae are accounted only from the time the candidate obtained the degree required for the position. Start and end dates of all previous positions and indication on whether they were full- or part-time should be clearly stated in the curriculum vitae. Details of any professional experience, training, research, or studies must be provided in the application. Upon request, candidates must be able to provide supporting documentation clearly indicating the duration and nature of those experiences.

#### 3. HOW TO APPLY

The applications must include:

- 1. Signed Legally Binding Statement (according to art. 46 of Italian D.P.R. 28.12.2000 n. 445) as per the attached template, declaring:
  - a. Age not exceeding (at the time of signing the contract) that required for retirement by local regulations (60 years), or by Italian regulations (ref. Law 398/87) for candidates subject to the Italian social security system (67 years);
  - b. Citizenship;
  - c. Being medically fit for employment;
  - d. Full enjoyment of political and civil rights;
  - e. Absence of convictions for any criminal offence and absence of any pending criminal charge both in Italy and abroad;
  - f. Not to have been dismissed, dispensed, declared lapsed or fired from employment in a public administration, both in Italy and abroad;
  - g. Not having sustained, in the three-year period preceding the date of expiry of the notice, an assessment of insufficiency in the assessment of work done/performed in the context of employment contracts signed with AICS offices other than Tunis.

Any false declaration will incur on penal sanctions according to article 76 of Italian D.P.R. n. 445 of 28.12.2000, as subsequently amended and supplemented, facing immediate termination of employment and loss of any wrongfully obtained benefit.

- 3. Signed and dated motivation letter in English;
- 4. Copy of valid passport.

The applicants should also provide a telephone number and an email address for communications and must notify AICS of any change occurred after the submission of the application.

# 4. EXCLUSION FROM SELECTION PROCEDURES

The following will determine exclusion from the selection procedure:

- a) Applications lacking any of the essential eligibility requirements;
- b) Application received after the deadline stated and in a modality other than that provided for in this announcement;
- c) Application documents not signed.

#### 5. EVALUATION OF APPLICATIONS

Once the terms of validity of the notice have elapsed, the AICS Tunis Regional Representative assesses the admissibility of the applications regarding the presence of the essential requirements and the absence of causes for exclusion. The exclusion is communicated to the concerned candidates.

Subsequently, the AICS Tunis Regional Representative appoints a selection committee composed of three members, who meet the requirements for autonomy and impartiality with respect to the candidates. The committee assesses the merits of the applications by assigning a maximum overall score of 100 points according to the following criteria:

# QUALIFICATIONS (Max 70 points)

Assessment of education, competences and professional experience, and possession of preferred requirements as indicated in the documentation submitted by the candidate, will be carried out according to the below parameters.

# Education - up to 10 points:

- 2 points for a 1st level Master's degree in addition to the essential one foreseen in the announcement and relevant to the field of interest;
- 3 points for a 2nd level Master's degree in addition to the essential one foreseen in the announcement and relevant to the field of interest;
- 5 points for a PhD;.

# Language skills - up to 10 points:

- 4 points for knowledge of written and oral English language at C2 (Common European Framework of Reference);
- 2 points for knowledge of written and oral Italian language at C2 (Common European Framework of Reference);
- 2 points for knowledge of written and oral Arabic language at A2 or above (Common European Frameworkof Reference), .
- 2 points for knowledge of written and oral French language at B1 or above (Common European Framework of Reference)

## Assessment of professional experiences – up to 40 points

- Maximum 20 points: 14 points for at least 60 months of relevant working experience in project monitoring, data collection, analysis and reporting and 2 points for each semester after 60 months for a max. of 6 points.
- Maximum 20 points: 14 points for at least 24 months of relevant professional experience working with international organizations, governmental and/or non-governmental aid bodies on socio-economic development and/or humanitarian relief projects and programmes, in developing countries and 2 points for each semester after 24 months for a max. of 6.

# Assessment of preferred requirements – up to 10 points

- 2 points for each semester working experience at the Directorate General for Development Cooperation and / or the Italian Agency for Development Cooperation, international organizations, the EU, and governmental and non-governmental bodies for a maximum of 6 points;
- 2 points for each semester of professional experience carried out in the country indicated in this vacancy notice and/or in fragile states and/or in the MENA region, for a maximum of 4 points.

# **INTERVIEW (Max 30 points)**

Only candidates scoring minimum 40 points under Essential Requirements (comprised of art. 2.1 - Qualifications and skills, and art. 2.2 - Professional experiences and competences), will be invited for an interview, after which a maximum score of 30 points is awarded. The interview shall take place at AICS Tunis Regional Office or via video conference (e.g., Teams, Skype, ZOOM) in the case of candidates who are unable to be in Tunis. The interview takes place via video conference (e.g., Teams, Skype, ZOOM).

The interview shall be held in the languages indicated in the call for applications and shall assess the applicant's knowledge and experience, his or her ability to carry out the tasks in question, the language and any other skills deemed necessary to assess the candidate's profile in relation to the post to be filled. The interview notice is sent by e-mail to the address indicated by the candidate at the time of application. Applicants shall not be entitled to reimbursement of any costs incurred in connection with the interview.

Applicants are not entitled to receive any reimbursement for any expenses incurred in attending the interview.

Following the interview, a ranking list will be drawn up of only those candidates who have scored not less than 18 points at the interview and a total of not less than 60% of the maximum mark (60 out of 100).

#### 6. RESULTS OF THE SELECTION

The candidate with the highest score in the ranking list is offered the position via mail. The ranking list remains valid for the duration of the Programme. In case of a decline by the selected candidate or an early termination of the contract, the office reserves the right to appoint another candidate from the ranking list - if the necessary financial resources are available.

In the event of equal scoring, the youngest candidate will be preferred.

The ranking list is published on AICS HQ and AICS Tunis Office websites.

In the employment contract stipulated between AICS Tunis Regional Office and the person selected after the selection process completion, it is possible for the parties to terminate the contract in the presence of a just cause, i.e., a fact of such seriousness as not to allow the continuation, even provisional, of the employment relationship.

In any event, the employee may terminate the employment relationship by giving one months' notice.

The employment contract must mandatorily provide for the commitment of the employee to
